My certifications include the title Certified Fraud Examiner and a member of its worldwide advisory board (Association of Certified Fraud Examiners). I am a certified Police Fitness Instructor from the Cooper Aerobic Institute and as an Instructor in International Narcotics Trafficking (H.I.D.T.A.) Academic achievements held include an A.S in Law Enforcement, from Quinsigamond Community College, a B.S. in Law Enforcement (Magna Cum Laude), from Northeastern University and an M.Ed. in Adult Education from Worcester State University.
