Presentation Objective	1. Identify what great leadership looks like, 2. List and discuss the characteristics all great leaders share, 3. Conduct a self-assessment as a leader, and 4. Commit to a leadership development plan.
Presentation Description	Great leaders motivate and inspire others to work as a team to accomplish the organization's mission. This requires a focus on the mission and a focus on your people. One key element shared by all exceptional organizations is personnel who have buy-in and a passion for the organization's culture and goals. How do great leaders create this passion and enthusiasm? This presentation reviews historical applications of leadership, identifies and discusses six key components of great leadership, and offers attendees the opportunity to conduct a self-assessment of their leadership abilities. Leadership pillars will be discussed to assist leaders in improving themselves, their departments, and their people - creating exceptional leaders and exceptional organizations!
Speaker Bio	Chuck Joyner was employed by the CIA from 1983 - 1987, and was a Special Agent with the FBI from 1987

until his retirement in October 2011. He has lectured internationally and throughout the U.S. on myriad law enforcement topics, has appeared on various news outlets and television as an expert commentator, and is a frequent contributor to law enforcement periodicals.

Chuck held increasingly responsible positions in both organizations. Chuck was in charge of critical incident programs for two major FBI field offices, which included SWAT, Evidence Response, Special Agent Bomb Technicians, Weapons of Mass Destruction, and Crisis Management. He has managed multi-agency critical incidents, planned and coordinated protection details of government officials, led tactical operations, and coordinated the FBI response to special events. Chuck created, developed, and managed a wide variety of training programs throughout his career.

Chuck was a member of the team that created the FBI's Leadership Development Program and taught at the inaugural program. Chuck holds a M.A. in Organizational-Industrial Psychology with an emphasis on the study of organizational leadership

Title of Presentation	Use of Force and Liability: or How Plaintiff's Attorneys Will Attack You
Length of Presentation	90 minutes
Presentation Objective	1. Identify the primary cause of officer deaths and injuries, 2. Identify factors that increase liability, 3. Discuss pertinent court cases guiding our Use of Force decision-making, 4. List three main areas of attack by plaintiff's attorneys, and 5. Develop a plan of action to prevent/defeat these attacks.
Presentation Description	The DOJ has increased its investigations of alleged excessive force and abuse by police departments, leading to more departments being placed under federal oversight. Media scrutiny of police use of force events has become even more intense and millions are paid out each year in excessive force lawsuits. If officers use too little force, they can be injured or killed. If officers use too much force, they and their departments face severe liability as well as possible criminal charges. This presentation will view landmark use of force events and recent court decisions providing guidance to officers in the "reasonable" use of force. The strategies used by plaintiff's attorneys will be presented, as well as the necessary step to minimize officer and departmental liability.

Speaker Bio

Chuck Joyner was employed by the CIA from 1983 - 1987, and was a Special Agent with the FBI from 1987 until his retirement in 2011. He is a recognized expert in use of force, and has lectured internationally and throughout the U.S. on myriad law enforcement topics.

Chuck is the author of "Advanced Concepts in Defensive Tactics: A Survival Guide for Law Enforcement," a frequent contributor to a number of law enforcement periodicals, and has appeared on news media and television as an expert commentator. He has testified in federal and state court as an expert witness

Chuck is a certified FBI Firearms, Defensive Tactics, Tactical, Chemical Agents, Physical Fitness, General Police, and Master Police Instructor. He is also a certified TASER Instructor and ASP Baton Instructor. He was a POST certified SWAT and sniper instructor. Chuck has provided use of force instruction to thousands of FBI agents, law enforcement officers, military personnel, and civilians. He was inducted into the martial arts Masters' Hall of Fame in 2006 as Instructor of the Year.
